Sir,

The undersigned is directed to convey the sanction of the President of India for Rs.4713.34 lakhs and to release an amount of **Rs.32,94,78,000/- (Rupees Thirty Two Crore Ninety Four Lakh Seventy Eight Thousand only)**, after adjusting the unspent balance of Rs.1418.56 lakhs, to the **Government of Rajasthan** as 1st installment of recurring grant-in-aid for the year 2016-17 under the Scheme of Post-Matric Scholarship to the students belonging to STs.



7. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
