6. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the **Government of Rajasthan** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976.
7. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
