Status report on implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 [for the period ending 31.01.2023]

Readiness of the States in the implementation of the Act:

- (i) An updated status of State-wise implementation of the Act is given in Annexure-I. As per the information collected till now;44,73,048 claims (43,03,576 individual and 1,69,472 community claims) have been filed and 22,65,770 titles (21,62,662 individual and 1,03,108 community titles) have been distributed.
- (ii) A total of 39,96,212 (89.34%) claims have been disposed of.
- (iii) A statement on claims received and distribution of title deeds in various states, as in **Annexure-II**, is being maintained.

(ii) State wise details of claims received, titles distributed and the extent of forest land for which titles distributed (individual and community), as on 31.01.2023, in major States, is indicated below:
