NGO Partnership system (NGO-PS) portal has been developed by NITI Aayog (erstwhile Planning Commission of India) in consultation with the various Ministries/ Departments, Government Bodies to facilitate Voluntary Organisations (VOs)/ Non-Governmental Organizations (NGOs) during their interaction with the Government in connection with requests for Government Grants under various schemes of the participating Ministries/ Departments. The portal also helps to create a data base of existing VOs / NGOs and to access information on various schemes of the participating Ministries/ Departments open for grants. Ministry of Tribal Affairs is also one of the participating Ministries.

2. All Voluntary Organisations (VOs)/ Non-Governmental Organizations (NGOs) are required to Sign Up (one time) on this NGO Partnership System (NGO-PS) portal of the Aayog at <http://ngo.india.gov.in>. The Unique ID No. which will be shown just after Signing Up with the portal, may please be noted. To be eligible for funding for 2015-16, VOs/NGOs running projects being funded by this Ministry will be required to have unique ID from NGO-PS.

3. State Governments are accordingly requested that before recommending the project proposals of NGOs for funding to this Ministry it may be ensured that the NGOs concerned have signed up on this portal and indicated their unique ID number. It may please be noted that proposals of only those voluntary organizations, who have

signed up on the portal, will be considered by this Ministry for grants for the year 2015-16 onwards.

As already mentioned in communication dated 28.07.2016, no funds will be released to any NGO, unless they have registered themselves on NGO Darpan portal, obtained their unique ID and intimated the same to this Ministry.


