Respected Sir,

This is in regarding processing of the applications of NGOs seeking grants under the scheme 'Grants in aid to Voluntary Organizations working for the Welfare of the Scheduled Tribes' of the Ministry for FY 2024-25.

2. I would like to inform you that the last date for submitting applications by the NGOs on the NGO portal for consideration of Grants in Aid for FY 2024-25 was till 31.07.2024. Concerned State Govt./ District Authorities were requested to ensure that the ongoing pending applications, if found suitable as per scheme guidelines, are processed on priority and disposed of before the expiry of timeline. State Govt/ District Authorities were reminded through various letters and email communications. Details of letters sent to State Govt/ District Authorities are as below:-

3. A video Conference meeting was also held on 15.10.2024, to discuss issues in taking time-bound action on pending applications lying in the account of State/ UT and Districts. During the VC meeting, it was requested to all the concerned to take necessary action on the pending applications lying in their account on NGO Grants Portal.

4. It is, however, observed that ongoing project applications are still lying unprocessed at State/ District Level in your state. Since the projects under consideration are ongoing ones, if found suitable, the same may be recommended by the Principal Secretaries of the concerned Department of the States. The status of applications, including those pending with the District & State Govt. authorities, in your State as on 08.11.2024 is as per Annexure.

5. As the financial year is coming to an end soon, I would solicit your cooperation and support in expediting the processing of the ongoing applications to MoTA for which physical inspection report and recommendation of district authorities have already been received and the applications are lying at the state level. You may please advise concerned district authorities to take up physical inspection of on-going projects first and take necessary action i.e recommendation/ rejection as soon as possible, **preferably within the month of November, 2024.**
