Subject: Monthly Summary of Principal Activities for April, 2021.

This is regarding important activities of Ministry of Tribal Affairs during the month of **April, 2021.**

2. Two Notes for EFC i.e. one for Central Sector Schemes and second for EMRS have been finalized and submitted to Ministry of Finance.

2.1 A review meeting was held under chairmanship of Secretary (Tribal Affairs) regarding operationalization of non-functional EMRSs during this month.

3. Follow-up on data entry at State level through Live Video Conferencing for onboarding "ADI-GRAMS" portal on project activities sanctioned under the Scheme of Development of PVTGs w.e.f. 2017- 18 onwards was held with all PVTG concentrated States/UTs.

4. During the month of April 2021, a draft SFC Memo of a new scheme "Marketing and Logistics Development for Promoting Tribal Products from North Easter Region" proposed by TRIFED has been Circulated on the Portal of Ministry of Finance.

5. National Scheduled Tribes Finance and Development Corporation (NSTFDC) provides concessional financial assistance to eligible Scheduled Tribes for undertaking Self-Empowerment Venture. NSTFDC channelizes its funds through Government owned State Channelizing Agencies (SCAs), nominated by the respective State/ UT Governments, National Cooperative Development Corporation, certain PSU Banks, Regional Rural Banks and others. In this regard, the status of targets and achievements for the year 2021-22 is as under :

* Initially, based on estimated fund availability, it was estimated that the Corporation would be able to disburse approx. ₹220.00 crore. However, disbursement target for the year 2021-22 is yet to be finalised by the Deptt. of Public Enterprises.

6. Under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 as per information received from State Governments, till 31.12.2020; **42,59,385 claims** (41,09,105 individual and 1,50,280 community claims) have been filed and **19,97,778 titles** (19,20,507 individual and 77,271 community claims) have been distributed. A total of **37,51,677** (88.08%) claims have been disposed of.

7. India@75: Four Events/activities were organised by the Ministry of Tribal Affairs for commemoration of 75 years of India's Independence i.e.India@75. The details in the enclosed Annexure.

8. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.

9. During the month of April, 2021; 57 E-files have been created by this Ministry in e-office.

1.	7 th April, 2021	Anamaya-Tribal Health Collaborative/ Delhi	Anamaya, the Tribal Health Collaborative was launched by Union Minister of Tribal Affairs Shri Arjun Munda and by Union Minister of Health and Family Welfare Dr Harsh Vardhan. This collaborative is a multi-stakeholder initiative of Tribal Affairs Ministry supported by Piramal Foundation and Bill and Melinda Gates Foundation (BMGF).It will converge efforts of various Government agencies and organisations to enhance the health and nutrition status of the tribal communities of India by facilitating the strengthening of primary healthcare systems and invest in tribal health research while also developing and deploying technology that will enable scale, improved governance and increased accountability. The collaborative aspires to contribute to India achieving its SDG 2 (Zero Hunger) and 3 (Good Health and Wellbeing) targets on nutrition and health respectively, by Year 2030.
2.	12 th April, 2021	Going online as Leaders (GOAL)/ (Leadership Talks by Community Influencers)	A motivational session was organized where one expert from Art of Living Foundation was invited and undertook familiarization session with shortlisted mentors and mentees. The objective was to raise the level of aspiration amongst mentors and mentees.
