This is regarding important activities of Ministry of Tribal Affairs during the month of **August, 2022.**

**Eklavya Model Residential Schools and Grants under Article 275(1) of the Constitution**

2 Project Appraisal Committee (PAC) meetings with 08 States to consider proposals submitted under Grants under Article 275(1) were held during this month.

2.1 One review meeting for implementation of the scheme of EMRS was held during the month.

**National Scheduled Tribes Finance and Development Corporation (NSTFDC)**

3. National Scheduled Tribes Finance and Development Corporation (NSTFDC) provides concessional financial assistance to eligible Scheduled Tribes for undertaking Self-Empowerment Ventures for their livelihood. NSTFDC channelizes its funds through Government owned State Channelizing Agencies (SCAs), nominated by the respective State/ UT Governments, National Cooperative Development Corporation, NABKisan Finance Ltd., certain PSU Banks, Regional Rural Banks and others. In this regard, the status of targets and achievements for the year 2022-23 is as under:

The disbursement target is based on estimated fund availability. It is estimated that the Corporation would be able to disburse approx. ₹240.00 crore. However, disbursement target for the year 2022-23 is yet to be finalised by the Deptt. of Public Enterprises.

During the month of August, 2022, the Corporation sanctioned projects worth ₹ 3.96 crore and disbursed ₹ 14.62 crore.

3.1 CMD, NSTFDC visited Patna (Bihar) and had a meeting with the Secretary & Director, ST and ST Welfare Deptt. Bihar regarding implementation of NSTFDC schemes in the State of Bihar.

3.2 Officials of NSTFDC attended a VC meeting conducted by Ministry of Tribal Affairs on 01.08.2022 along with the officials of Canara Bank and office bearers of the concerned Voluntary Organisations regarding revised procedure for flow of funds under the Central Sector Schemes – Grant-in-Aid to Voluntary Organisations working for welfare of Scheduled Tribes. Another physical meeting held on 23.08.2022 was also attended with the officials of Ministry and Canara Bank regarding operationalization of Flow of Fund under the revised procedure.

3.3 NSTFDC organised “Har Ghar Tiranga” campaign at Ranchi (Jharkhand) in collaboration with Jharkhand Urban Infrastructure Development Company Ltd. (JUDCO) on 13.08.2022.

3.4 NSTFDC observed Swachta Pakhwada from 01.08.2022 to 15.08.2022. During this Swachta Pakhwada, CMD NSTFDC along with other officials planted various trees at DDA Park, R K Puram.

3.5 90th Board Meeting of the Corporation was held on 25.08.2022.

### **Forest Rights Act**

4. Under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 as per information received from State Governments till 31.03.2022, 44,29,065 claims (42,60,247 individual and 1,68,818 community claims) have been filed and 22,34,292 titles (21,32,217 individual and 1,02,075 community claims) have been distributed. A total of 38,92,431 (87.88%) claims have been disposed of.

### **PVTG**

5. Project Appraisal Committee meeting for appraisal and approval of the Annual Plan/CCD Plan for FY2022-23 under the Scheme of Development of PVTGs in respect of States was held during the month.

### **Har Ghar Tiranga Campaigan**

6. Under ‘Har Ghar Tiranga’ Campaign, Staff of the Ministry as well as beneficiaries of the Schemes/Programmes being implemented by the Ministry were encouraged to hoist Tiranga at their homes to mark 75<sup>th</sup> years of Independence of the Nation. Folowing Activities were carried out in the Ministry under the said campaign :

- a. SMS were sent to all more than 30 lakh scholarship beneficiaries, Panchayti Raj Institution representatives, NGOs for flag hoisting.
- b. Instructions were issued to all States, TRIs, NGOs and EMRSs for Har Ghar Tiranga programme.
- c. The National Flags were made available to all employees of Ministry of Tribal Affairs for Har Ghar Tiranga Programme.

7. **Swachhata Pakhwada** was celebrated in the Ministry from 01<sup>st</sup> August 2022 to 15<sup>th</sup> August 2022. Activities like Planting of Trees, Swachhata Message at vantage locations, Cleanliness of Corridors of the Ministry, Weeding out of Old Files was carried out during the Swachhata Pakhwada.

8. **Sadbhawana Diwas** was observed in the Ministry on 18.08.2022 wherein a Pledge taking ceremony, administered by Secretary (TA) was organized.

9. In line with making E-Governance as an essential part of Digital India, during the month of August, 2022, 105 e-files have been created by this Ministry in e-office.
