Subject: Monthly Summary of Principal Activities for November, 2020.

This is regarding important activities of Ministry of Tribal Affairs during the month of November, 2020.

2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs. 37.66 Crores as on 30th November, 2020 for the year 2020-21. The total Annual target for the year, 2020-21 is Rs. 245.00 Crores.

3. As per information received from State Governments, till 30.06.2020; 42,52,154 claims (41,03,001 individual and 1,49,123 community claim) have been filed and 19,85,632 titles (19,09,249 individual and 76,383 community claims) have been distributed. A total of 37,40,997 (87.98%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

Activities carried out for EMRS:

4.1 Revised Guidelines for EMRS scheme has been issued during the month.

4.2 Construction Committee Meeting was held during the month to review the ongoing construction of EMRSs.

4.3 Three meetings were held during the month to discuss the progress of procurement of tabs and finalize technical aspects, specification of the tablets to be procured through GeM.

5. Ministry of Tribal Affairs has included 14 new items under the MFP list and fixed the minimum support price (MSP) for the same taking the total items covered under MSP to 87.

6. The meeting of Members of SGoS on Welfare was held on **10th Nov, 2020** for discussion on agenda items as per the minutes of meeting chaired by Cabinet Secretary with all members of Sectoral Group of Secretaries - 5 (Welfare). Before this, the meeting of AS/JS level Officers of this Group was held on **6th Nov, 2020** for discussion and finalization of the agenda items for the SGoS meeting.

7. This Ministry has prepared the Concept Note alongwith the Action Plan on "**Adi Gram Swaraj Abhiyan**" on the lines of Gram Swaraj Abhiyan aimed at filling critical gaps in basic services and facilities in villages that have a sizeable tribal population and this Concept Note and the Action Plan has been forwarded for Cabinet approval during the month.

8. On 26th November, 2020; this Ministry observed the Constitution Day wherein the officers and staffs read the Preamble of the Constitution.

9. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.

10. During the month of November, 2020; 122 e-files have been created by this Ministry in e-office.
