**Subject: Monthly Summary of Principal Activities for September, 2020.**

This is regarding important activities of Ministry of Tribal Affairs during the month of **September, 2020.**

2. As per the information received, "National Scheduled Tribes Finance and Development Corporation (NSTFDC)" disbursed loan of Rs. 31.62 Crores as on 30<sup>th</sup> September, 2020 for the year 2020-21. The total Annual target for the year, 2020-21 is Rs. 245.00 Crores.
3. As per information received from State Governments, till 31.03.2020; 42,51,545 claims (41,02,437 individual and 1,49,108 community) have been filed and 19,83,504 titles (19,07,126 individual and 76,378 community) have been distributed. A total of 37,36,057 (87.88%) claims have been disposed of under the ST and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.
4. Ms. Sudha Painuli, Vice Principal, EMRS Kalsi, Uttarakhand was awarded with **National Award to Teachers, 2020 by Hon'ble President of India.**
5. **Logo, Moto and Uniform for EMRS** designed by NIFT were finalized during the month.
6. During the month three services of National Fellowship scheme made live on **UMANG** (Unified Mobile Application for New Age Governance) Platform. This is one of the key initiatives under Digital India programme to develop a common, unified platform and mobile app to facilitate a single point of access to all Government services.
7. Meeting with State/ UT Governments was held through Video Conferencing during the month on **issues related to impact of COVID- 19 Pandemic on the Tribal Communities.**
8. A review meeting with Pr. Secy / Secy of all the Tribal Welfare/Affairs Departments of the States/UTs held under the Chairpersonship of Secretary, Tribal Affairs, through VC on 02.09.2020 to review **various schemes/aspects including PVTG, FRA, SCA to TSS, grants under Art 275 (1) and EMRS**, with the focus being on the first two themes.
9. Meeting between Secretaries of MoTA and MoEFCC on the issues of **implementation of FRA, 2006** was held on 10.09.2020 in office of Secretary, MoTA, Shastri Bhawan, New Delhi.
10. A meeting of Members of SGoS on Welfare was held on 16th September, 2020 for discussions on **progress made in implementation of 5 Year vision document.**
11. Officials of NSTFDC visited Odisha Gramya Bank, Bhubaneswar for identification of eligible refinance cases under NSTFDC schemes and visited also to Rani (Assam) for selection of beneficiaries for Skill Development Programme on alternative Livelihood Promotion of 25 ST Women.
12. 81st and 82nd Board Meetings of NSTFDC was held during the month.
13. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS.
14. During the month of September, 2020; 171 e-files have been created by this Ministry in e-office.
