Subject: Monthly Summary of Principal activities for October, 2018.

1. As per information received from State Governments till 31.10.2018, 42,10,378 claims (40,64,741 individual and 1,45,637 community claims) have been filed and 18,79,372 titles (18,08,819 individual and 70,553 community claims) have been distributed. A total of 38,19,864 (90.72%) claims have been disposed of.
2. National Scheduled Tribes Finance and Development Corporation (NSTFDC) has disbursed loan of Rs.24.21 crores till the month of October, 2018. The total Annual target for the year 2018-19 is Rs. 220.00 crores.
3. NSTFDC has organized a "Run for Unity" programme to commemorate the birth anniversary of Sardar Vallabhbhai Patel at Rourkela (Odisha) on 31.10.2018. The "Run for Unity" was flagged off by Shri Jual Oram, Hon'ble Minister of Tribal Affairs and was also attended by official of NSTFDC.
4. Incumbency details of all posts in the Ministry and its organizations falling under ACC purview have been updated on AVMS. There has been no case in which ACC directions have not been complied with.
5. During the month of October 2018, 214 E-files have been created by this Ministry in e-office.
