- 2. The maximum age limit for the appointment on deputation basis shall be 56 years as on the closing date of receipt of applications. The pay and the other terms and conditions of the appointed candidate will be as per DoPT's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.
- 3.
