Sir / Madam,

In continuation of this Ministry's letter of even no. dated 05.07.2023 on above mentioned subject (copy attached), it is to say that the last date for recommending the ongoing project proposals for FY 2022-23 was upto 21.07.2023.

2. It is, however, observed that ongoing project proposals are still lying unprocessed at State/ District Level in your state. The status of the applications pending for necessary action is as under:

3. In view of the above, it has been decided to extend the last date for recommendation of ongoing projects for FY2022-23 to 28.07.2023. Further extension beyond this time may not be considered as this ministry is likely to open NGO grant portal for inviting applications for Grant-in-Aid for ongoing project proposals for the year 2023-24 by the end of this month, this may not be feasible to invite two-year project proposals simultaneously.
