Sir,

I am directed to convey the sanction of the President of India for Sanction of **Rs. 320.50 Lakhs to Release an amount of Rs.143.25 Lakhs (Rupess One hundred forty three lakhs twenty five thousand only)** as the 1st instalment for the year 2017-18, under the Central Sector 'Scheme of Grant-in-aid to TRIs' to Scheduled Caste and Scheduled Tribe Research & Training Institute, Govt. Of Odisha, Bhubaneswar The details of the activities approved by the Ministry for the year 2017-18 is at Annexure enclosed.

2. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Odisha in accordance with procedure laid down in the Ministry of Finance's O.M No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by O.M of even number dated 16.9.1976.
3. A representative of the Ministry shall be invited to participate in the Seminar/Workshop organized by the Odisha/State Government from time to time.
4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other purpose/activities.
5. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
6. No Utilization Certificate (UC) has been rendered due and pending. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-C in terms of GFR 2017.

7. The expenditure is debitable to the Major Head 3601 - Grants-in-aid to state Government, 06 – Grants for Centrally Sponsored Scheme (Sub Major Head), 796 – Tribal area Sub Plan (Minor Head), 34 – Umbrella Programme for Development of Scheduled Tribes : Support to Tribal Institution, 02 – Support to Tribal Research Institutes, 34.02.31 – Grants-in-aid General (Charged) under Demand No. 96 of the Ministry of Tribal Affairs for the Year 2017-18.

8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.

9. The sanction is issued in concurrence with the Integrated Finance Division, Ministry of Tribal Affairs vide their FTSDy. No.3737/JS&FA/14 dated 19.07.2017
