
2. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of Telangana in accordance with procedure laid down in the Ministry of Finance's O.M No. 2(45)/76-Spl Cell dated 30.8.1976 as modified by O.M of even number dated 16.9.1976.
3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
4. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
5. No Utilization Certificate (UC) is due at this stage. The Utilization Certificate (UC) should be submitted as per Rule 239 of GFR in form 12-c in term of GFR 2017.
