Subject :- Release of Final Installment of grants-in-aid for the year 2017-18 under Central Sector Scheme of "Support to Tribal Research Institutes (TRIs)" to Chhattisgarh for the year 2017-18.

Sir,

I am directed to convey the sanction of the President of India to release an amount of **Rs. 1,68,73,000 (Rupees. One crore sixty eight lakh seventy three thousand only)** as Final Installment of grants-in-aid under Central Sector Scheme of "Support to TRIs" to Tribal Research and Training Institute, Raipur, Govt. of Chhattisgarh, to carry out the activities approved by APEX committee of the Ministry in its meeting dated 27.11.2017. The details of the activities approved by the Ministry for the year 2017-18 is at Annexure enclosed.

2. You may please transfer the amount immediately to the Government of Chhattisgarh and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Chhattisgarh in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to TRI Division of the Ministry.
3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
4. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.

The expenditure is debitable to the Major Head- 3601 Grants in aid to State Governments, 06- Grants for Centrally Sponsored Scheme (Sub Major Head), 796- Tribal Area Sub Plan (Minor Head)- 34 – Umbrella Programme for Development of Scheduled Tribes: Support to Tribal Institution, 02- Support to Tribal Research Institutes, 34.02.31 - Grants in aid General (Charged) Under Demand No. 96 of the Ministry of Tribal Affairs for the year 2017-18.
7. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.


