Sir,

In continuation of this Ministry's sanction letter of even number dated 25.07.2017 I am directed to convey the sanction of the President of India to release an amount of **Rs. 89,78,000 (Eighty Nine Lakh Seventy Eight Thousand Rupees only)** as 2<sup>nd</sup> / Final Installment of grants-in-aid under Central Sector Scheme of "Support to TRIs" to Tribal Research Institute, (TR&DI), Bhopal, Government of Madhya Pradesh for the year 2017-18 to carry out the activities approved by APEX committee of the Ministry in its meeting dated 02.06.2017. The details of the activities approved by the Ministry for the year 2017-18 is at Annexure.

2. You may please transfer the amount immediately to the Government of Madhya Pradesh and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Madhya Pradesh in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to TRI Division of the Ministry.
3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
4. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.



9. Certified that this sanction order has been noted at S. No.-22 in the register of grant for the year 2017-18.


