6. The State Government shall release the funds to concerned EMRS immediately. Further, the State Government shall ensure that funds are utilized for imparting quality education to the tribal students in EMRSs as stipulated in the EMRS Guidelines, 2010 after following due procedure in a transparent manner.
7. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated and revised from time to time. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry immediately after closure of current financial year by the State Government.
8. State Government shall ensure immediate transfer of funds to respective implementing agencies for implementation of activities approved by MoTA. Progress Reports of the grants under Article 275(1) of the Constitution may be furnished in the format prescribed by MoTA. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR), 2017 amended from time to time.
9. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their **FTS No. 11985/JS&FA/2018 dated 28.06.2018.**
