Sir,

I am directed to convey the sanction of the President of India to release an amount of **Rs. 5,25,000/- (Rupees Five Lakh Twenty Five Thousand only)** of Grants-in-aid General under Centrally Sponsored Scheme of "Support to TRIs" to Government of Tamil Nadu for undertaking activities under Poshan Abhiyan 2018-19 as reflected in TRI Tamil Nadu's letter No. PDL 2/2018 dated. 29.08.2018.

2. You may please transfer the amount immediately to the Government of Tamil Nadu and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Tamil Nadu in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to TRI Division of the Ministry.

3. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.

4. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.

5. No UC is due for rendition.

6. The expenditure is debitable to the Major Head -3601 Grants in aid to State Governments, 06-Grants for Centrally Sponsored Scheme (Sub Major Head), 796- Tribal Area Sub Plan (Minor Head)-34 – Umbrella Programme for Development of Scheduled Tribes: Support to Tribal Institution, 02-Support to Tribal Research Institutes, 34.02.31 – Grants-in-aid General (Charged) Under Demand No. 96 of the Ministry of Tribal Affairs for the year 2018-19.

7. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.


