7. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of **Government of Mizoram** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.

8. No utilization certificate is due for rendition.

9. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
