7. You are requested to advise RBI, CAS, Nagpur for crediting the above-mentioned amount to the account of **Government of Kerala** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.
