Sir,

In continuation of the Ministry's sanction order dated 26.12.2018, sanction of the President of India is hereby conveyed to release an amount of **Rs.3,22,00,000/- (Rupees Three Crore Twenty-two Lakh only)** towards final & 2nd installment of arrear grants for the year 2016-17 & 2017-18, and 1st installment of 2018-19, to the **Government of Telangana** under the Centrally Sponsored Scheme of **Pre-Matric Scholarships to ST students**, during the current financial year 2018-19.


2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitible to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2018-19 :-

9. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
