Subject: Release of scholarship amount to National Institute of Technology, Kurukshetra under the Central Sector Scholarship Scheme of National Fellowship and Scholarship for Higher Education for ST Students for the year 2016-17 (Fresh), 2016-17 (Renewal of 4th year of 2013-14 Batch), 2017-18 (Fresh) during the year 2018-19.

Sir,

I am directed to convey the sanction of the President of India for releasing recurring and non-recurring scholarship amount Rs.1,91,200/- (**Rupees One Lakh Ninety One Thousand Two Hundred Only**) to **National Institute of Technology, Kurukshetra** under the Central Sector Scholarship Scheme of National Fellowship and Scholarship for Higher Education for ST Students as per details given in **Annexure** for the year 2016-17 (Fresh), 2016-17 (Renewal of 4th year of 2013-14 Batch), 2017-18 (Fresh) during the year 2018-19, subject to the following terms and conditions:


(ii) The above amount is being released since it has been brought to the notice of this Ministry that an amount of Rs.1,91,200/- which was available as unspent balance with NIT Kurukshetra was deducted twice. Firstly, the amount of Rs.1,91,200/- was adjusted as unspent while releasing Rs.4,59,200/- vide Sanction Order No. 11021/33/2007-Sch dtd. 23.07.2018. Subsequently, vide Ministry's sanction order No 11021/02/2014-Edu/Sc dtd. 16.10.2018 and No. 11021/33/2007-Sch dtd. 10.10/2018, an amount of Rs.1,37,000/- and Rs.54,200/- respectively (totalling Rs.1,91,200/-) was adjusted. Thus, an amount of Rs.1,91,200/- was adjusted twice, requiring sanctioning of Rs.1,91,200/- adjusted inadvertently. Hence, this amount is being released to the Institute with this sanction for disbursement of scholarship to the concerned students.

(iii) No UC is due for rendition. The scholarship for subsequent financial year will be released only after utilization certificate in the prescribed format in respect of grant of preceding financial year is submitted by the Institute to the satisfaction of this Ministry.

(iv) The Institute shall not obtain grant for the same purpose or activity from any other Ministry or Department of Government of India or State Government.

(v) The Institute shall not divert the funds released under the scheme to another Institute or institution for implementation of scheme. No funds out of this grant shall be utilized for any new scheme for which prior approval of Government has not been obtained.

(vi) The Institute shall make reservations for SCs/STs/OBCs and the Disabled in the posts or services under its control for the implementation of scheme on the lines indicated by the Government of India.

(vii) The Institute shall furnish to this Ministry progress report (Performance-cum-achievement report) of students indicating both physical and financial achievement under the scheme.

(viii) The accounts of the Institute shall be open to inspection by the sanctioning authority by the Internal Audit Wing of Office of Chief Controller of Accounts of this Ministry and Comptroller and Auditor General of India under Section 14 of the C&AG of India (Duties, Powers and Condition of Service) Act, 1971 and law of PRAO (HRD) New Delhi, whenever the Institute is called upon to do so.

(ix) If the Government is not satisfied with the progress or considers that the conditions of sanction are being violated, it reserves the right to terminate the sanctioned scheme or debar the Institute from future grant or any other financial assistance from the Government.

(viii) It is further certified that scholarship amount to the grantee is sanctioned in accordance with pattern of financial assistance approved and is in conformity with the rules and principles of the scheme as approved by the Ministry and provisions of General Financial Rules as amended from time to time.

2. Unspent Balance

- a) Certified that the unspent balance of ₹NIL from the grant sanctioned during the previous years has been adjusted in this year's grant.
- b) Unspent balance from this grant will be adjusted from the subsequent grant.

3. The Drawing & Disbursing Officer of this Ministry is authorized to draw an amount of **₹1,91,200/- (Rupees One Lakh Ninety-One Thousand and Two Hundred Only)** to National Institute of Technology, Kurukshetra the grantee institution through telegraphically directly in their Account No-10116885013, IFSC – SBIN0006260 Name of Bank – State Bank of India, Bank Address – NIT, Kurukshetra, Dist- Kurukshetra, Haryana, 136119.

The Expenditure is debitable to Major Head “2225” Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes and Minorities (Major Head), 02 – Welfare of Scheduled Tribes (Sub Major Head), 796 – Tribal Area Sub Plan (Minor Head), 15– Central Scholarship, 01-National Fellowship and Scholarship for Higher Education of ST students – 15.01.34 – Scholarships under Demand No. 96 – Ministry of Tribal Affairs for the year 2018-19.
