
Sir,

You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of the Government of West Bengal in accordance with procedure laid down in the Ministry of Finance's OM No.2(45)/76-Spl Cell dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to this Ministry.
