Subject:- Release of Rs. 1,04,65,200/- (Rs. One Crore Four Lakh Sixty-Five Thousand Two Hundred only) to TRIFED towards participation of TRIFED in Gramoday Mela at Chitakoot, Madhya Pradesh for the year 2018-19 under the scheme "Tribal Festival, Research Information & Mass Education".

Sir,

I am directed to convey the sanction of the President of India for the release an amount of **Rs. 1,04,65,200/- (Rs. One Crore Four Lakh Sixty-Five Thousand Two Hundred only) to Tribal Cooperative Marketing Development Federation of India Limited (TRIFED)** towards participation on behalf of the Ministry in Gramoday Mela to be organized by Deendayal Research Institute (DRI), New Delhi from 24th to 27th February, 2019 at Chitrakoot, Madhya Pradesh for the year 2018-19 under the scheme "Tribal Festival, Research Information & Mass Education".

2. The sanctioned fund is subject to following conditions: -


- i. Availability of funds in the relevant budget head is ensured;
- ii. TA/DA to be regulated as per extant TA/DA rules;
- iii. Pooled vehicles like buses/vans to be utilized for local travel;
- iv. GFR provisions are complied with; &
- v. Due economy to be exercised in r/o overall expenditure.

3. TRIFED is directed to utilized this fund for the purpose for which it is released.

4. The Grant-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2017 (GFRs), as amended from time to time, read with the Government of India's decisions incorporated there-under and any other guidelines which may be issued in this regard, and in particular to conditions under GFR- 232, along with the following:

I) Certified that the pattern of assistance of rules governing such grant-in-aid have received the approval of the Ministry of Finance, as required under Government of India Decision No. (1) under DFPR- Rule 20.

II) Assets acquired wholly or substantially out of Government Grants shall not be disposed off without obtaining the prior approval of the sanctioning authority of Grant-in-aid.

III) The accounts of the grantee organization shall be audited by the Comptroller & Auditor-General of India (C&AG) or by any person authorized by him on his behalf in accordance with the provision laid down in section 14 of the C&AG (Duties, Power & Conditions of Service) Act, 1971 as amended from time to time.

IV) The accounts of the grantee organization shall be open for inspection by the sanctioning authority and audit, both by the Comptroller & Auditor General of India under the provisions of C&AG (DPC) Act, 1971 and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

V) The grantee organization will spend the grants-in-aid exclusively in pursuance of the objectives envisaged in the scheme for the purpose it is being sanctioned.

VI) Grant-in-aid to the grantee organization is subject to the economy instructions issued from time to time by the Ministry of Finance or by the Competent Authority.

VII) The grantee organization has no utilization certificate as due for rendition under the rules.

VIII) In the event of the grantee organization failing to comply with the conditions, it shall be liable to refund to the sanctioning authority the whole of the amount of the grant with interest at 10% per annum thereon.


IX) The grantee organization will maintain a separate account of the Government grant as per guidelines of the scheme.

5. A Utilization Certificate of the grant received for the purpose, for which it was sanctioned, is to be furnished by the TRIFED immediately after completing the above mela.

6. The Drawing and Disbursing Officer, Ministry of Tribal Affairs, is authorized to make payment for **Rs. 1,04,65,200/- (Rs. One Crore Four Lakh Sixty-Five Thousand Two Hundred only)** in favour of Tribal Cooperative Marketing, Development Federation of India Limited (TRIFED), 2nd Floor, NCUI Building, 3, Siri Institutional Area, August Kranti Marg, New Delhi- 110 016. The payment may be made to their Bank **Account no.- 1111240677, IFSC Code: CBIN0280296, MICR Code: 110016034** to Central Bank of India, Branch Name- Panchsheela Park Branch, New Delhi-110017 through ECS/RTGS/NEFT/CBS by PAO who will render the bills in due course for adjustment.

7. The expenditure is debitable to the Major Head "2225", Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities (Major Head), 02 Welfare of Scheduled tribes (Sub Major Head), 796 Tribal Area Sub Plan (Minor Head), 21- Umbrella programme for Development of Schedule Tribes: Van Bandhu Kalyan Yojana, 04- Tribal Festival, Research Information & Mass Education, 21.04.50- Other Charges under Demand No. 96 of the Ministry of Tribal Affairs for 2018-19.

8. The sanction is issued in exercise of delegated power in consultation with the Integrated Finance Division, Ministry of Tribal Affairs vide ID no. 13917/JS&FA/2018 dated 14.02.2019 and Ministry of Finance, Department of Expenditure ID Note 19(29)/E.Coord/2019 (1048930) dated 14/02/2019.
