You may please transfer the amount immediately to the Government of Sikkim and advise RBI, CAS, Nagpur for crediting the above mentioned amount to the accounts of the State Government of Sikkim in accordance with the procedure laid down in the Ministry of Finance's OM No. 2(45)/ 76-Spl. dated 30.8.1976 as modified by OM of even number dated 16.9.1976 under intimation to TRI Division of the Ministry.
3. No UC is due for rendition.
4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.
5. As per Rule 236(1) of GFR-2017, the accounts of the Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
6. The payment of **Rs. 13,00,000/- (Rupees Thirteen Lakh only)** to the Government of Sikkim will be made by a bank Draft in favour of Secretary, Department of Finance, Gangtok. The Drawing & Disbursing Officer of the Ministry of Tribal Affairs will present a bill of Rs. 13,00,000/- to the pay & Account Officer, Ministry of Tribal Affairs to enable him to issue a Draft.
7. The expenditure is debit to the Major Head -3601 Grants in aid to State Governments, 06- Grants for Centrally Sponsored Scheme (Sub Major Head), 796- Tribal Area Sub Plan (Minor Head)- 34 – Umbrella Programme for Development of Scheduled Tribes: Support to Tribal Institution, 02- Support to Tribal Research Institutes, 34.02.35 - Grants for creation of capital assets (Charged) Under Demand No. 96 of the Ministry of Tribal Affairs for the year 2018-19.
8. The financial assistance sanctioned is provisional subject to final adjustment on the basis of audit figures of expenditure.
9. The sanction is issued in concurrence with the Integrated Finance Division, Ministry of Tribal Affairs vide their FTS No. -12193/JS&FA/2018, dated 31.12.2018.
