
Sanction of the President of India is hereby conveyed to release an amount of **Rs.20,00,000/- (Rupees Twenty Lakh only)** to the UT Administration of **Dadra and Nagar Haveli** as 1st installment of recurring grant-in-aid towards 1st instalment of arrear grants for the years 2016-17 and 2017-18 under the Scheme of **Pre-Matric Scholarship to ST students**.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitab'le to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2017-18:-


