Sanction of the President of India is hereby conveyed to release an amount of **Rs.1,56,00,000/- (Rupees One Crore Fifty-Six Lakh only)** to the **Government of Madhya Pradesh** under the Centrally Sponsored Scheme of Pre - Matric Scholarships to Scheduled Tribe students as arrear for the year 2017-18 and 1<sup>st</sup> Installment for the year 2018-19.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

9. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
