7. The amount will be drawn by the **UT Administration of Daman and Diu** in accordance with the procedure laid down in the Ministry of Finance (Department of Expenditure) O.M. No.1(9)/7/86-CA/1099 dated 30-01-1976 and as modified vide OM of even number dated 16-09-1976 under intimation to this Ministry.

8. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
