In continuation of this Ministry's sanction letter No. 20015/02/2012-Edu/Sch. dated 26.09.18, Sanction of the President of India is hereby conveyed for Rs.3588.67 lakh and to release an amount of **Rs.34,05,92,000/- (Rupees Thirty-Four Crore Five Lakh Ninety-Two Thousand only)** as per availability of funds, toward recurring grant to the **Government of Odisha** under the Centrally Sponsored Scheme of **Pre-Matric Scholarships to Scheduled Tribe students** for 2018-19 as arrear (2nd Installment).

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

The State Government shall ensure that the Scholarship funds received from the Government of India / Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's O.M. No. I-11011/58/2013-DBT dated 27.08.2015. A copy of the release order should be sent by email on edu-tribal@nic.in.

7. You are requested to advise RBI, CAS, Nagpur for crediting the abovementioned amount to the account of **Government of Odisha** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.

8. As per Rule 236(1) of GFR-2017, the accounts of the Institution / Organization shall be open to inspection by the sanctioning authority and audit, both by the comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the principal accounts office of the Ministry or Department, whenever the institution or organization is called upon to do so.


9. No utilization certificate is due for rendition.
