I am directed to convey the sanction of the President of India and to release grant-in-aid of **Rs.42,27,750/- (Rupees Forty Two Lakh Twenty Seven Thousand Seven Hundred Fifty only)** as recurring grant, as per availability of funds to the **UT Administration of Ladakh** towards 1st instalment (50% of total central share) for the year 2020-21 under the Centrally Sponsored Scheme of **Pre-Matric Scholarships to Scheduled Tribe students** during the current Financial year 2020-21.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.



7. The amount will be drawn by the **UT Administration of Ladakh** in accordance with the procedure laid down in the Ministry of Finance (Department of Expenditure) O.M. No.1(9)/7/86-CA/1099 dated 30-01-1976 and as modified vide OM of even number dated 16-09-1976 under intimation to this Ministry.
