Sub: Grants-in-aid being released to the State **Government of Jharkhand** towards as arrear for the year 2019-20, 2020-21 and 1st installment (25% of Central Share) for the year 2021-22 under the Centrally Sponsored Scheme of Post Matric Scholarships to Scheduled Tribe students during the current financial year 2021-22.

I am directed to convey the sanction of the President of India to release grant-in-aid of **Rs.94,35,28,000/- (Rupees Ninety Four Crore Thirty Five Lakh Twenty Eight Thousand only)** as recurring grant, as per availability of funds to the **Government of Jharkhand** towards as arrear for the year 2019-20, 2020-21 and 1st installment (25% of Central Share) for the year 2021-22 under the Centrally Sponsored Scheme of **Post Matric Scholarships to Scheduled Tribe students** during the current Financial year 2021-22.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

3. The expenditure is debitable to the Major Head Grant, sub-head as indicated below and shall be met from Plan Budget for the year 2021-22 :-

6. Scholarships are payable to the ST according to the Guidelines of the Scheme. The State Government shall ensure that the Scholarship funds received from the Government of India / Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's O.M. No. I-11011/58/2013-DBT dated 27.08.2015. A copy of the release order should be sent by email on edu-tribal@nic.in.

7. You are requested to advise RBI, CAS, Nagpur for crediting the above-mentioned amount to the account of **Government of Jharkhand** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.

8. As per Rule 236(1) of GFR-2017, the accounts of the Institution / Organization shall be open to inspection by the sanctioning authority and audit, both by the comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the principal accounts office of the Ministry or Department, whenever the institution or organization is called upon to do so.

9. No utilization certificate is due for rendition.

10. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.


