I am directed to convey the sanction of the President of India and to release grant-in-aid of **Rs.4,32,37,717/- (Rupees Four Crore Thirty Two Lakh Thirty Seven Thousand Seven Hundred Seventeen only)** as recurring grant, as per availability of funds to the **Government of Mizoram** towards as arrear for the year 2020-21 and 1st Installment (50% of Central Share) for 2021-22 under the Centrally Sponsored Scheme of **Pre-Matric Scholarships to Scheduled Tribe students** during the current Financial year 2021-22.

2. This sanction relates to Plan Expenditure and is in accordance with the pattern of assistance prescribed by the Planning Commission and subject to the provision of General Financial Rules, 2017 as amended from time to time and any other instructions issued in this regard.

7. You are requested to advise RBI, CAS, Nagpur for crediting the above mentioned amount to the account of **Government of Mizoram** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.
