

4. The grant should be utilized for the purpose for which it has been sanctioned and should not be diverted for any other activities.



The expenditure is debitable to the Major Head - 3601 Grants in aid to State Governments, 06- Grants for Centrally Sponsored Scheme (Sub Major Head), 796- Tribal Area Sub Plan (Minor Head)- 34 – Umbrella Programme for Development of Scheduled Tribes: Support to Tribal Institution, 02- Support to Tribal Research Institutes, 34.02.35 – Grant for Creation of Capital Assets (Charged) Under Demand No. 99 of the Ministry of Tribal Affairs for the year 2021-22.
