
In continuation of this Ministry's letter even dated 12.10.2022, I am directed to convey the sanction of the President of India for release of an amount of **Rs. 27,93,16,000/- (Rupees Twenty Seven Crore Ninety Three Lakh and Seventeen Thousand only)**, to the Government of Gujarat towards Creation of Capital Assets-(CCA) for **Grants under Article 275(1) of the Constitution** for the year 2022-23 to carry out the following activities: -

Ongoing projects as per State Govt. proposal-

PAC advised the state to ensure that selection of beneficiary is done in a transparent manner and activities to be undertaken in consultation with Skill Development Department. It was clarified that grant under Article 275(1) is being released to the State, without any particular reference to any implementing partner/agency. It is for the implementing department of the State Government to decide about the best way to implement. In particular, the selection of any non-government organization must be done in a transparent and competitive manner. It must be made clear to such selected entities that Central Government or this Ministry does not have any liability to the personnel engaged in such training; nor is this Ministry obliged to continue any such activity in future.

It is clarified by the State that cost of the project is to be shared with GoI and state in 50:50 ratio. PAC advised the state to ensure that selection of beneficiary is done in a transparent manner and there is no duplication of beneficiary.

The project should be implemented with the State Department of Animal Husbandry. The state should ensure that as far as feasible, local breed of cattle should be provided in the Dairy Development project as the Gujarat state is the pioneer in protection and promotion of indigenous animals.

It was observed that the total cost per school is around Rs. 15 cr and state has demanded only Rs. 6 cr per school from MoTA and balance amount to be borne by the State. PAC advised that instead of cost sharing for each school, State may revise the proposal and get full funding for a particular unit from MoTA instead of part funding. However, the Secretary, Tribal Development Department, Government of Gujarat stated that in the past also Central grants have been given for such constitution where State has also contributed. It was approved with the condition that the Tribal Development Department, Government of Gujarat will obtain technical sanction and administrative approval for the entire project from the Competent authority. The State Component should be provided in time so that the projects are not delayed. Quality of construction must be got supervised through reputed institutions like IIT/NIT. Support staff to run these institutions should also be sanctioned by the State Government through its own resources.







5. The State Government will implement the projects within the amount released by the Ministry during 2022-23 and keeping in view the spirit of the provisions contained under Operational Guidelines for Inter-State allocation of funds and implementation of Programmes / Activities under Proviso to Article 275(1) of Constitution of India, issued by Ministry of Tribal Affairs vide this Ministry's letter NO. 18015/06/2019-Grants dated 23.04.2020 and other relevant instructions issued from time to time.

6. State Government shall ensure immediate transfer of funds to respective implementing agencies for implementation of activities to be approved by MoTA PAC / Competent Authority. Progress Reports of Grants under Article 275(1) of Constitution of India may be furnished in the format prescribed by MoTA. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per provisions of General Financial Rules (GFR), 2017 amended from time to time.

7. Article 275(1) Grants is an additive to State Plan funds and efforts for Tribal Development. Funds under Article 275(1) Grants must be utilized for raising socio-economic

level of Schedule Tribes commensurate with objectives enshrined in para 2.1 and 2.2 of revised guidelines dated 23.04.2020.


8. The State Government has to ensure that grant-in-aid is used for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/ State Acts, Rules, regulations, etc. In case of construction of infrastructure facilities, norms and Schedule of Rates (SOR) fixed by the State Government should be followed.

9. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated and revised from time to time. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry as per provision of GFR 2017.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their FTS No. 23084/JS&FA/2022 dated 09.02.2023.


