- The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned.
- State Government shall ensure immediate transfer of funds to respective implementing agencies for setting up of PMU. Progress Reports of the grants released under the Scheme may be furnished. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR), 2017 amended from time to time.

9. The expenditure to the tune of **Rs. 26,00,000/- (Rupees Twenty Six Lakh Only)** is debitable to the


