The State Government shall ensure that the Scholarship funds received from the Government of India / Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's O.M. No. I-11011/58/2013-DBT dated 27.08.2015. A copy of the release order should be sent by email on edu-tribal@gov.in.

7. You are requested to advise RBI, CAS, Nagpur for crediting the above-mentioned amount to the account of **State Government of Telangana** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.

8. As per Rule 236(1) of GFR-2017, the accounts of the Institution / Organization shall be open to inspection by the sanctioning authority and audit, both by the comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and Internal audit by the principal account's office of the Ministry or Department, whenever the institution or organization is called upon to do so.

9. No utilization certificate is due for rendition.

10. Diversion of funds and deviation from the norms of the scheme shall not be allowed. State Government has no authority to divert the funds for other purpose.
