**Subject:-** Release of Grants in Aid - General (Charged) under Centrally Sponsored Scheme of "Support to Tribal Research Institutes (TRIs)" to Uttarakhand for the year 2023-24.

Sir,

I am directed to convey the sanction of the President of India to release an amount of **₹2,95,54,000 (Rupees Two Crore Ninety Five Lakh Fifty Four Thousand Only)** as 4<sup>th</sup> installment (Grants in Aid – General (Charged)) under Centrally Sponsored Scheme of "Support to TRIs" to Government of Uttarakhand for the year 2023-24 for payment of rental charges of IIPA (NTRI Building) against the period from October 2023 to February, 2024. The APEX committee of the Ministry in its meeting dated 06.09.2023 had approved various activities, the details of which are as under:

**2.1.1. Committed Liabilities:**

The Apex Committee examined the proposal of the TRI with respect to the committed liabilities. It was noted that an amount of ₹590.09 lakh has not yet been released out of the approved amount for the TRI since the year 2021-22. Only ₹235.00 lakh is being sought out of ₹590.09 lakh in the proposal of the TRI Uttarakhand as follows:


