**Subject:-** Release of Grants-in-Aid for Creation of Capital Asset (Charged) under Centrally Sponsored Scheme of "Support to Tribal Research Institutes (TRIs)" to Nagaland during the year 2024-25.

Sir,

I am directed to convey the sanction of the President of India for releasing an amount of **₹1,00,00,000 (Rupees One Crore Only)** as 1<sup>st</sup> instalment as Grant-in-Aid for Creation of Capital Asset (Charged) under Centrally Sponsored Scheme of "Support to TRIs" to Government of Nagaland for the year 2023-24 during the year 2024-25 to carry out the activities approved by APEX Committee of the Ministry in its meeting dated 06.09.2023 & 31.10.2023. The details of the activities are as under:

Quality of construction, should be regularly monitored by a third party reputed organization like Govt. Engineering College/NIT. Technical sanction and administrative approval should be obtained from the competent authority. State Government should also sanction necessary staff for running and maintaining the TRI and this should be ensured to be done so as to ensure that the TRI building is ready for use immediately on completion.




