The State Government shall ensure that the Scholarship funds received from the Government of India/Ministry of Tribal Affairs are released directly to the beneficiaries electronically as laid down in Union Ministry of Finance's Office Memorandum No. I-11011/58/2013-DBT dated 27/08/2015. A copy of the release order should be sent by email on edu-tribal@nic.in.

You are requested to advise RBI, CAS, Nagpur for crediting the above-mentioned amount to the account of **State Government of Karnataka** in accordance with procedure laid down in the Ministry of Finance's OM No. 2(45)76-Spl.Cell dated 30-8-1976 as modified vide OM of even number dated 16-09-1976.
