
Sir,

I am directed to convey the sanction of the President for release of an amount of **Rs 1,97,50,000/- (One Crore Ninety-Seven Lakh Fifty Thousand Only)** to the **State Government of Jharkhand** towards Grant-in-aid-General (GGA) under the Scheme of "**Administrative Costs to States/UTs**" for the year 2024-25 for setting up of State PMU in the state.

2. The grant-in-aid shall be subject to provision of GFR2017.
3. The state PMU shall be set up in accordance with the guidelines of the scheme issued by the Ministry of Tribal Affairs.
4. The Utilization Certificate for recurring grant will be submitted by the State Govt. to the Ministry as per Rule 239 of the GFR 2017 in Form G FR-12-C.
5. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned.
6. State Government shall ensure immediate transfer of funds to respective implementing agencies for setting up of PMU. Progress Reports of the grants released under the Scheme may be furnished. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR). 2017 amended from time to time.
7. You are requested to advise RBI, CAS, Nagpur for crediting the above-mentioned amount to the account of the Government of Jharkhand in accordance with procedure laid down in the Ministry of Finance's OM No.2(45)/76Sp1Cell dated 30.08.1976 as modified by OM of even number dated 6.9.1976 under intimation to this Ministry.
8. No UC is due for rendition as this is the 1<sup>st</sup> release under the scheme.
