Subject: Release of fund under the Scheme of Development of Administrative Costs to States/UTs - Grant-in-aid-General (GGA) to Government of Madhya Pradesh for the year 2023-24 during FY 2024-25.

Sir,

I am directed to convey the sanction of the President of India and to release grants-in-aid of an amount of Rs 2,10,00,000/- (Two Crore Ten Lakh Only) to the State Government of Madhya Pradesh towards Grant-in-aid-General (GGA) under the Scheme of "Administrative Costs to States/UTs" for the year 2023-24 during FY 2024-25 for setting up of State PMU in the state.

2. Rs.400.00 lakh was allocated to the state for the FY 2023-24, However, Rs. 100 lakhs was released to the State Govt. of Madhya Pradesh under the scheme "Administrative Cost to States/UTs" for FY 2023-24 Vide sanction no 48016/1/2022-Estt dated 28.12.2023. Now Rs.210.00 lakh is being released out of balance amount of Rs.300.00 lakh for FY 2023-24 during 2024-25.

2. The state PMU shall be set up in accordance with the guidelines of the scheme issued by the Ministry of Tribal Affairs.
3. The Utilization Certificate for recurring grant will be submitted by the State Govt. to the Ministry as per Rule 239 of the GFR 2017 in Form G FR-12-C.
4. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned.
5. State Government shall ensure immediate transfer of funds to respective implementing agencies for setting up of PMU. Progress Reports of the grants released under the Scheme may be furnished. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR). 2017 amended from time to time.
