Subject: Grants under Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN)-(MPCs) during 2024-25 to the State Governments (Creation of Capital Assets).

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.58,04,09,500/- (Rupees Fifty-Eight Crore Four Lakh and Nine Thousand Five Hundred only)** to the State Governments of Andhra Pradesh, Gujarat, Jharkhand, Karnataka, Maharashtra, Rajasthan, Tamil Nadu, Telangana, Tripura and Uttarakhand towards Creation of Capital Assets **under Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) (MPCs)** during the year 2024-25 for the purpose of setting up of **471** Multi-Purpose Centres (MPCs) (at the unit cost up to Rs. 60 lakh subject to cost arrived as per transparent process with due procedure for arriving at the cost) which are as follows:

5. The State Government will implement the projects within the amount released by the Ministry during 2024-25 and keeping in view the spirit of the provisions contained Multi-Purpose Centre (MPC) under PM JANMAN Implementation Guidelines for State Government /UT Administration, issued by Ministry of Tribal Affairs vide this Ministry's letter No. 14012/17/2023-PVTG dated 11.01.2024 and other relevant instructions issued from time to time along with the conditions stipulated in the Annexure.

6. The financial assistance as provided under the scheme has been approved by Ministry of Finance. It shall be utilized for the purpose it has been sanctioned and for the welfare of members of PVTGs only.

7. State Government shall ensure immediate transfer of funds to respective implementing agencies for implementation of activities approved by MoTA. Progress Reports of the grants released under the Scheme of PM-JANMAN may be furnished in the format prescribed by MoTA. A Certificate of actual utilization of the grants received for the purpose, for which it has been sanctioned, is to be furnished to the Ministry as per Rule 239 of General Financial Rules (GFR), 2017 amended from time to time. State Govt. shall also ensure to comply with all the conditions stipulated by the MoF vide O.M. No.1 (13)PFMS/FCD/2020 dated 23.03.2021, as amended from time to time, regarding procedure for release of fund under Centrally Sponsored Schemes (CSS).

8. The State Governments have to ensure that grants-in-aid is utilized for the purpose for which it is sanctioned after following due procedure in a transparent manner and after obtaining all necessary clearances as required under the various Central/State Acts, rules, regulations etc. In case of infrastructure facilities, norms and schedule of rates (SoR) fixed by the State Government to be followed. The construction must be carried out only on Government / Public land.

9. The progress reports of every quarter should be furnished indicating the physical and financial progress as per prescribed format already circulated and revised from time to time. A Certificate of actual utilization of the grants received for the purpose for which it was received, may be furnished to the Ministry as per provision of GFR 2017.

10. This sanction issues in exercise of the delegated powers in consultation with Integrated Finance of the Ministry of Tribal Affairs vide their **FTS No. 26919/JS&FA/2025 dated 25.02.2025.**

Annexure

- i. The State to ensure and conform that the land identified for the purpose is adequate for construction of the centre and ownership of the land has been transferred in the name of State TWD;
- ii. In case of infrastructure facilities, norms and schedules of rates (SoR) fixed by the State to be followed. The construction must be carried out only on Government/Public Land.
- iii. Recommendation of DLCC and approval of Principal Secretary on the proposal to be obtained and furnish to this Ministry;
- iv. Construction of the Centre is carried out by State Govt. Agency or any other agency identified by the State following the prescribed procedure and fiscal prudence in a transparent manner as per stipulated timeline;
- v. Construction cost of the Centre including furniture, fixture, fittings and other basic requirements for the centre does not exceed Rs. 60 lakh.
- vi. The State is to submit estimated cost details according to the Schedule of Rates (SoR) within the prescribed ceiling with the certificate that the proposed rates have been vetted by the technical Department;
- vii. State will also ensure that all necessary clearances whether under Central or State Act/Rules/Regulations is obtained by the State.
- viii. State will ensure technical scrutiny of estimates for the work is done by competent authority as per provisions of DFPR applicable in the State and project is executed by Govt. agency in transparent manner.
- ix. The State TWD will submit detailed report to MoTA after complying the above stipulations by the Ministry. A dedicated module has been created in PM Gati Shakti Portal. The data in respect of these MPCs need to be updated on the PM Gati Shakti Portal. The financial and physical progress of the MPC needs to be updated on the portal.
- x. Whether there is Anganwadi or Mini Anganwadi with Staff and Anganwadi and Anganwadi is Kachha, the same will be shifted to the MPC. Further, if there is Puca Anganwadi with Staff in the same habitation/village where MPC is approved, no separate staff for Anganwadi will be provided in the MPC.
- xi. The State TWD will submit detailed proposal to MoTA after complying the above stipulations for consideration and sanction by the Ministry.
- xii. The State should finalise mechanism for maintenance of these MPCs as per guidelines and coordinate with the concerned line departments for provision of staff.
